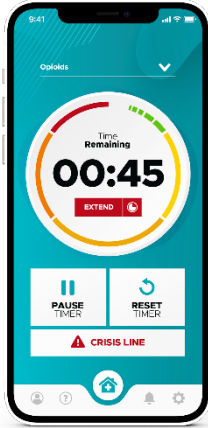

'LIFEGUARD' APP SAVES OVERDOSING B.C. MAN'S LIFE, TWICE



'Lifeguard' app saves overdosing B.C. man's life, twice

Rowan Buffet (alias) was using fentanyl to ease severe pain in his leg. The Lifeguard app he downloaded alerted White Rock firefighters of his location after he had blacked out. They were able to save his life twice thanks to Lifeguard.

"According to BC Emergency Health Services, as of Feb. 28 there have been a total of 3,705 unique Lifeguard app users, and 30,113 all-time sessions. To date, Lifeguard usage has prompted 60 emergency responder calls and 14 overdose reversals."

SUSPECTED BENZODIAZEPINE IN FENTANYL



There has been an increase in overdoses in Chilliwack. These overdoses appear to be associated with a bluish green substance being sold as fentanyl.

The substance may be contaminated with benzodiazepines. Naloxone may not fully reverse the effects of an overdose with this substance.

Program Updates

MENTAL HEALTH AND SUBSTANCE USE SERVICES

- The Virtual Health Addictions Clinic (VHAC), which opened March 24th, 2020, continues to see great success in increasing access to addiction medicine support through support provided to community Opioid Agonist Treatment clinics, Emergency Response Centres and Isolation Centres. Between November 2020 and January 2021, VHAC saw 180 unique clients for 483 visits and started / restarted 99 individuals on OAT
- The Fraser South Rapid Access to Addictions Care (RAAC) in Surrey remains one of the busiest addictions clinics in the province, with 549 Opioid Agonist Treatment inductions completed in the period between November 2020 and January 2021. This model has now expanded to the Fraser North RAAC at the Royal Columbian Hospital MHSU Wellness Centre in New Westminster.

EMERGENCY NETWORK

- Approximately 157 ED Nurses and Physicians participated in the 2-part Trauma & Resiliency Informed Practice (TRIP) in Emergency workshop. Emergency Network and Mental Health and Substance Use leads conducted a formal evaluation of this in partnership with the Mental Health Commission of Canada. The course has been received extremely well by staff and the official report and analysis will be released in March 2021. We are integrating TRIP into standard staff orientation, procedures and policies
- Seven Fraser Health Emergency Department teams are participating in the provincial Learning about Opioid Use Disorder (LOUD) in ED project. The aim is to improve care to people who present to ED who have opioid use disorder and increase the accessibility of buprenorphine-naloxone through Emergency Departments
- A 2-part virtual Harm Reduction in Emergency course will be rolled out in February and March, 2021 for all ED staff, with staff wages funded by the LOUD initiative. This will align with Fraser Health's new Harm Reduction Policy.
- Continued spread and education for ED staff around Safer Injection Kits, Take Home Naloxone and buprenorphine-naloxone (Suboxone) through ongoing safety huddles, inservices and education sessions.
- Distributed Opioid Response Newsletter (Dec. 2020) focused on Harm Reduction, Safer Injection kits and TRIP to ED staff and MHSU leads.
- ED Network is in the process of developing a regional standardized course for orientation of new staff with an overview of opioid response, trauma informed practice, resiliency, safety conversations, addiction, Opioid Agonist Treatment and Harm Reduction. Launching April 16, 2021.

FATAL OVERDOSES

According to the BC Coroners Service, there were 52 suspected illicit drug toxicity deaths in Fraser Health in January 2021 (Table 1). This is a 148% increase from the number of deaths reported in the same month last year, with 21 deaths in January 2020. Compared to 2020, the largest increases in January 2021 were in Maple Ridge, Abbotsford, and Burnaby.

Illicit drug toxicity deaths reported by BC Coroners Service include illicit drug overdoses involving street drugs (heroin, cocaine, MDMA, methamphetamine, etc.), medications that were not prescribed to the deceased, combinations of the above, with prescribed medications, and those overdoses where the origin of drug is not known.

^Community assigned based on location of overdose and if that is missing, location of death.

OVERDOSES ATTENDED BY BC AMBULANCE

NOTE: Starting with the July 2019 report, Fraser Health's surveillance definition of suspected overdose events attended by BC Ambulance Service has been modified to include only probable opioid overdose events and suspected overdose events excluding medication overdoses.

In December 2020, BC Ambulance Services responded to 554 overdoses across Fraser Health. The total number of ambulance-attended overdoses in Fraser Health increased by 21% in 2020 compared to 2019. Almost all Fraser Health communities saw marked increases in overdoses, especially Delta, New Westminster, and Agassiz/Harrison (see Table 2).
