

TOXIC DRUG POISONING RESPONSE PUBLIC REPORT, SEPTEMBER 2023

ILLICIT DRUG TOXICITY DEATHS

- According to BC Coroners Service, there were 49 illicit drug toxicity deaths in Fraser Health in September 2023.
- This is a 4% decrease from the number of deaths reported in the previous month, with 51 deaths in August 2023.
- Compared to 2022, the greatest increases in (projected) drug toxicity deaths in 2023 have been seen in Chilliwack (+22%) and New Westminster (+21%) (Table 1).




Figure 1: Illicit drug toxicity deaths within Fraser Health, January 2013 to September 2023



PARAMEDIC-ATTENDED TOXIC DRUG POISONING EVENTS

- Paramedics responded to 597 suspected toxic drug poisoning events across Fraser Health in September 2023; this is a 6% increase compared to the average of the previous 12 months (Table 2).
- Compared to 2022, the greatest increases in the projected rate of paramedic-attended toxic drug poisoning events in 2023 have occurred in Chilliwack (+33%), Port Coquitlam (+25%), and Hope*** (+16%) (Table 2).
- Compared to 2022, the largest decreases in the projected rate of paramedic-attended toxic drug poisoning events in 2023 have occurred in City of Langley (-33%), Abbotsford (-27%), and Mission (-27%) (Table 2).
