END OF RESPIRATORY ILLNESS SEASON

What's changed

- Lifting of visitor proof of vaccination
- Removal of visitor Rapid Point of Care Testing
- Lifting of visitor universal masking requirements
- Removal of screening practices for visitors
- Staff masking scaled back to Point of Care Risk Assessment
- Remove all COVID-19 signage



END OF RESPIRATORY ILLNESS SEASON

What's not changed

- Mandatory Immunization for staff
- Point of Care Risk Assessment and standard precautions
- Infection prevention best practices
- Availability of masks and alcohol-based hand sanitizer
- Staff and visitors to stay home if ill



PUBLIC HEALTH

- Follow-up processes for COVID cases in LTC/AL stay the same:
 - Enhanced monitoring (self-monitoring, with Public Health support)
 - Enhanced monitoring with additional measures
 - Outbreak declared
- Measures related to masking after universal masking requirement is lifted
 - Enhanced monitoring-self-monitoring: Pre-pandemic approach, masking is required as per standards for droplet precautions
 - Enhanced monitoring with Public Health support masking will be <u>recommended (not required)</u> for all staff/visitors/contractors on an affected unit
 - If concerning trends, additional measures can be taken at the discretion of MHO, which may include masking requirement for all staff/visitors/contractors
