

2024 CARE COMMUNITY AWARDS

Fraser Health Care Community requests nominations for outstanding individuals in Care Communities. Nominees can include: Care Community Medical Directors (CCMDs), Most Responsible Practitioners (MRPs), leadership and staff (e.g. Directors of Care/Manager, care aides, housekeeping, dietary, recreation, etc.).

The goal of the awards is to recognize individuals who demonstrate exemplary contributions to improve quality of life for Care Community residents and embodies the values of comfort, caring, and connection. Examples can include but are not limited to: quality of care, leadership, innovation, quality improvement, resident and family-centred care, team collaborator, "quiet heroes", volunteers or staff in non-leadership roles.

Awards available will recognize individuals from each region (Fraser North, Fraser South, and Fraser East) for a maximum of nine awards across Fraser Health Care Community.

Nominations will be received until April 3, 2024 at 12:00 PM. Individuals nominated must be:

- 1. An active staff member or volunteer of a Fraser Health Owned and Operated or Affiliated Care Community.
- A physician or clinician in good standing with the corresponding regulatory body (e.g. College of Physicians and Surgeons of British Columbia, British Columbia College of Nurses & Midwives) as applicable.

\*Please note that members of the Physician Leadership Team or the Fraser Health Executive, including Directors, are not eligible for nomination.

To submit a nomination, provide the reasons for your nomination and a brief summary, biography, and/or resume about the nominee.

Letters of support can come from colleagues, administration, medical or allied care community staff, residents or families.
