All food businesses must obtain approval from Fraser Health prior to operating a business. This includes, but is not limited to – restaurants, food stores, processing plants, mobile food trucks, food service at temporary events and vendors at farmers markets or other temporary markets. Fraser Health Environmental Health Officers are available to assist at any time in the process.

How can we help?

Our website provides useful information for approval and operation of a food business such as:

- Approval procedure for new food operators, including application for health approval, application package for food service, temporary food premises application and more.


